## Comprehensive School Safety Plans vs. Emergency Operations Plans

While there are many commonalities between Comprehensive School Safety Plans (CSSP) and Emergency Operations Plans (EOP), they are very different documents that serve different functions. Districts are required to have both plans in place to comply with state law. That being said, both plans share some similarities and are equally important as it relates to overall emergency management.

Comprehensive School Safety Plans are required by California law. The elements of a CSSP were recently amended as a result of Assembly Bill 1747 (Rodriguez), School Safety Plans (effective January 1, 2019). In order to comply with the amended bill, schools must meet the requirements listed in California Education Code sections

32280–32289. CSSPs are required to be updated annually, and they incorporate elements of the District's Emergency Operations Plan.

Emergency Operations Plans are a requirement of the Standardized Emergency Management System (SEMS), which came about as a result of Senate Bill 1841 in 1993. Known as the Emergency Services Act (Government Code § 8607) requires Districts to use SEMS to receive reimbursement of disaster-related personnel costs.

Creating and maintaining a current CSSP and EOP is a technical and time-consuming task. Plan managers must have specific knowledge and training to ensure that their plans are relevant as well as compliant with state and federal requirements. Unfortunately, most plan managers are faced with limited time and resources, making this task nearly impossible.
