

SB 390 Security Officer Certification Course



Beginning July 1, 2021, SB 390 requires **all school security officers and security guards** who are employed by or work on the property of a school district, charter school, county office of education, or community college district, to complete a training developed by the Bureau of Security and Investigative Services of the Department of Consumer Affairs in consultation with the Commission on Peace Officer Standards and Training, regardless of the number of hours worked per week.

Certification Course Goals

The IMReady™ certification course is designed to help California school and community college security guards meet the requirements of SB 390, through a customized live interactive training conducted in their work environment.

The course exactly follows the most recent curriculum developed by BSIS, to include the following learning objectives and goals:

- Role and Responsibility of School Security Officer
- Laws and Liability
- Security Awareness in the Educational Environment
- Mediation/Conflict Resolution
- Disasters and Emergencies
- Dynamics of Student Behavior
- Examination

Components of the Course

- 24 hours of live instruction (3 consecutive 8 hour days)
- The course is instructed by former law enforcement officers. All instructors hold a current California POST (AICC) certification.
- This course is conducted in accordance with requirements and guidelines set forth in SB 390.

Take Aways

Upon completion of this course, attendees will:

- Have a basic understanding and awareness of security involving youth in a school environment
- Meet the minimum requirements for security officers employed by a school district, charter school, county office of education, or community college district, and security guards working on the property of a school district as defined in SB 390

Course attendees receive a SB 390 Certificate of Completion upon meeting the following requirements:

- 100 percent course attendance (24 hours total)
- Completion of the course exam with a minimum score of 80%
